Dear Honorable Secretary General Mr. Ban Ki Moon:

As a group of concerned Libyans, we offer our most sincere gratitude for your expression of concern about recent developments in Libya of increased military activities and your call for a dialogue by all Libyan parties.

Three years after the fall of the Qaddafi regime, the Libyan people have not been able to establish viable democratic institutions, and a functioning state. The crisis at present has reached alarming levels and threatens the peace and security, not only of Libya but also of North Africa, the Sahel countries and the Mediterranean. The prospects of an intractable civil war are looming, and Libya is on the brink of becoming a failed state at the center of a critical region of the World.

We are writing to you to seek the counsel and immediate intervention of the United Nations and the International community.

We are grateful for the on going engagement by the UN in Libya, the G7 Leaders statement made in Brussels today, and for recent envoys dispatched by the EU, USA, UK, and the Arab League, including UK Ambassador Jonathan Powell and U.S Ambassador David Satterfield who are currently in Libya to assess the situation on the ground.

Clearly, the political and security situation in Libya is dire and requires IMMEDIATE CONSTRUCTIVE AND ACTIVE INTERNATIONAL INTERVENTION. The mission of such intervention, however, must be under the UN and in accordance to UN Security Council resolutions.

We are proposing the following immediate steps:

- 1- Strengthen and expand the mandate of the UNSMIL, under the existing UN resolutions adopted in 2011, to actively convene a conference of all Libyan armed militias and all key political groups. In such conference the UN would start and directly administer a credible and serious process of national reconciliation, disarmament, and amnesty programs between all parties in order to go beyond all grievances of the past including those before February 17, 2011. The UN should act, as the neutral party Libya needs now the most and take the lead in managing and guaranteeing the enforcement of any outcome by all means referenced in the current active resolutions with the support of the International Community.
- 2- UN should guide a new political road map and democratic mechanisms for the establishment of a legislative body as soon as possible that can replace the current General National Congress (GNC) and provide direct support and effective guidelines for the nominations, elections and congressional conduct for the new parliament.
- 3- The UN should provide more direct and active support for the new constitution's drafting and ratification process, already in place by the recently elected committee in charge of drafting the constitution, as well as greater support for the adoption of the new constitution in a national referendum to be managed by the UN.
- 4- Work closely with the national army of Libya, under the authority of a newly elected Parliament and its nominated government to stabilize the country and create viable and secure Libyan territories for all its civilian population whom may potentially be caught within the warring factions in different regions of the country.
- 5- Support the inclusion of all Libyans regardless of beliefs or political opinion in the process of a peaceful political transition including all political exiles and war refugees.

We look forward to hearing your reply and we stand ready to meet with you to discuss the urgent matters contained herein and help achieve stability and security in Libya.

A. Omar Turbi (Fathi) recognized for lobbying and credited for persuading the U.S. government to take part in NATO operations during the February 17<sup>th</sup>, 2011 revolution. He communicated with the US Congress, the White House, U.S Department of State, and other branches of the U.S Government, and carried his message on major international media like PBS/News Hour, BBC. He is a frequent commentator on CNN, BBC Al-Jazeera and other major TV and radio networks. Turbi arranged for the safe entry for CNN news into eastern Libya the 1<sup>st</sup> week of the revolution <a href="https://www.youtube.com/watch?v=hgP0Gro52c8">https://www.youtube.com/watch?v=hgP0Gro52c8</a> causing one the largest rallies in Benghazi 2-23-2011. The 1<sup>st</sup> major televised event.

Turbi served as an advisor to the **National Transitional Council (NTC)** during the first eights months of the Libyan revolution, and diligently provided humanitarian and assistance. Since the start of the Libyan revolution in February, 2011, Turbi relentlessly lobbied the U.S and EU governments for intervention to save Libyan civilians, and remove the Qaddafi regime. Late March 2011, he helped draft U.S Congressional resolution HR188 and pushed for recognition of the interim **National Transitional Council (NTC)** as the legitimate representative of the Libyan people.

Turbi is a distinguished Arab American, recognized for his support for democratic institutions and Arab causes in the U.S. He is a member of the National Advisory Board of American-Arab Anti Discrimination Committee, (AADC), a Chairman Emeritus of the Arab American Republican Club. He served on the board of Trustees of the World Affairs Council of America. Turbi, is a prominent human rights activist with a keen interest in Libyan, Arab and western affairs. A founding member of the Libyan Human Rights Commission The Commission gained prominence when it delivered the 1<sup>st</sup> ever, intervention speech in the history of the UN Human Rights Committee in February, 1989. The Commission helped secure political asylum for hundreds of Libyans in Western Europe throughout the nineties

Turbi promoted constructive engagement between the U.S and Libyan governments and delivered testimonies to Congress in 1999, and 2004 and participated in think tanks paving the way for the release of 413 political prisoners in 2001, and the safe entry by thousands of opponents to the Libyan regime into Libya for the next seven years.

He holds an engineering degree in power systems (BSEE) from the University of Wisconsin, in addition to graduate work in business and international relations. He worked for IBM, and later Motorola, where he learned Six Sigma Quality Systems and became expert in off shore high technology manufacturing. He is currently President & CEO of Orbit Systems, Inc. a semiconductor, computer products, and IT services, commercial & defense based in California.
